ORDER

On August 19, 2008, Complainants Teresa Ramsey and Linda Riley (collectively "Complainants") filed complaints against their former employer, Respondent Plaza Jewelers, Inc. d/b/a Reflections Jewelers ("Respondent"), alleging employment discrimination on the basis of race and national origin in violation of the Cook County Human Rights Ordinance ("Human Rights Ordinance"). On November 5, 2007, the Cook County Commission on Human Rights ("Commission") entered an order finding substantial evidence of a violation of the Human Rights Ordinance with respect to the Complainants' terminations and set the matter for a joint hearing on the merits.

On March 24, 2009, Hearing Officer Richard J. Gonzalez reported to the Commission that the parties had entered into a written settlement agreement resolving the case. *See Exhibit A.* Complainants further indicated that Respondent was in breach of that settlement agreement, and Complainants were pursuing a breach of contract claim in the Circuit Court of Cook County. Complainants wished to withdraw their complaints from the Commission, and Hearing Officer Gonzalez recommended granting Complainants' request for dismissal.

For the foregoing reasons, the Commission hereby ADOPTS Hearing Officer Gonzalez's recommendation and DISMISSES complaints 2006E030 and 2006E031 pursuant to a VOLUNTARY WITHDRAWAL.



RECOMMENDED ORDER DISMISSING COMPLAINT
