AGREEMENT

This Agreement is made and entered into by and between the County of Cook, a public body corporate of the State of Illinois, on behalf of Office of the Chief Procurement Officer, hereinafter referred to as "County" and SENTINEL OFFENDER SERVICES, LLC., doing business as a(an) Corporation of the State of Illinois, hereinafter referred to as "Contractor".

BACKGROUND

The County of Cook issued a Request for Proposals "RFP" for Electronic Monitoring. Proposals were evaluated in accordance with the evaluation criteria published in the RFP. The Contractor was selected based on the proposal submitted and evaluated by the County representatives. Contractor represents that it has the professional experience and expertise to provide the necessary services and further warrants that it is ready, willing and able to perform in accordance with the terms and conditions as set forth in this Agreement.

NOW, THEREFORE, the County and Contractor agree as follows:

TERMS AND CONDITIONS

ARTICLE 1) INCORPORATION OF BACKGROUND

The Background information set forth above is incorporated by reference as if fully set forth here.

ARTICLE 2) DEFINITIONS

a) Definitions

The following words and phrases have the following meanings for purposes of this Agreement:

"Additional Services" means those services which are within the general scope of Services of this Agreement, but beyond the description of services required under Article 3, and all services reasonably necessary to complete the Additional Services to the standards of performance required by this Agreement. Any Additional Services requested by the Department require the approval of the Chief Procurement Officer in a written modification to this Agreement before Contractor is obligated to perform those Additional Services and before the County becomes obligated to pay for those Additional Services.

"Agreement" means this Professional Services Agreement, including all exhibits attached to it and incorporated in it by reference, and all amendments, modifications or revisions made in accordance with its terms.

"Chief Procurement Officer" means the Chief Procurement Officer for the County of Cook and any representative duly authorized in writing to act on his behalf.

"Department" means the Cook County Using Department.

"Services" means, collectively, the services, duties and responsibilities described in Article 3 of this Agreement and any and all work necessary to complete them or carry them out fully and to the standard of performance required in this Agreement.

"Subcontractor" means any person or entity with whom Contractor contracts to provide any part of the Services, including subcontractors and subconsultants of any tier, suppliers and materials providers, whether or not in privity with Contractor.

b) Interpretation

i) The term **"include"** (in all its forms) means "include, without limitation" unless the context clearly states otherwise.

ii) All references in this Agreement to Articles, Sections or Exhibits, unless otherwise expressed or indicated are to the Articles, Sections or Exhibits of this Agreement.

iii) Words importing persons include firms, associations, partnerships, trusts, corporations and other legal entities, including public bodies, as well as natural persons.

iv) Any headings preceding the text of the Articles and Sections of this Agreement, and any table of contents or marginal notes appended to it, are solely for convenience or reference and do not constitute a part of this Agreement, nor do they affect the meaning, construction or effect of this Agreement.

v) Words importing the singular include the plural and vice versa. Words of the masculine gender include the correlative words of the feminine and neuter genders.

vi) All references to a number of days mean calendar days, unless expressly indicated otherwise.

c) Incorporation of Exhibits

ARTICLE 3) DUTIES AND RESPONSIBILITIES OF CONSULTANT

a) Scope of Services

This description of Services is intended to be general in nature and is neither a complete description of Contractors Services nor a limitation on the Services that Contractor is to provide under this Agreement. Contractor must provide the Services in accordance with the standards of performance set forth in Section 3c. The Services that Contractor must provide include, but are not limited to, those described in Exhibit 1, Scope of Services and Time Limits for Performance, which is attached to this Agreement and incorporated by reference as if fully set forth here.

b) Deliverables

In carrying out its Services, Contractor must prepare or provide to the County various Deliverables. "Deliverables" include work product, such as written reviews, recommendations, reports and analyses, produced by Contractor for the County.

The County may reject Deliverables that do not include relevant information or data, or do not include all documents or other materials specified in this Agreement or reasonably necessary for the purpose for which the County made this Agreement or for which the County intends to use the Deliverables. If the County determines that the Contractor has failed to comply with the foregoing standards, it has 30 days from the discovery to notify Contractor of its failure. If Contractor does not correct the failure, if it is possible to do so, within 30 days after receipt of notice from the County specifying the failure, then the County, by written notice, may treat the failure as a default of this Agreement under Article 9.

Partial or incomplete Deliverables may be accepted for review only when required for a specific and well-defined purpose and when consented to in advance by the County. Such Deliverables will not be considered as satisfying the requirements of this Agreement and partial or incomplete Deliverables in no way relieve Contractor of its commitments under this Agreement.

c) Standard of Performance

Contractor must perform all Services required of it under this Agreement with that degree of skill, care and diligence normally shown by a contractor performing services of a scope and purpose and magnitude comparable with the nature of the Services to be provided under this Agreement. Contractor acknowledges that it is entrusted with or has access to valuable and confidential information and records of the County and with respect to that information; Contractor agrees to be held to the standard of care of a fiduciary.

Contractor must assure that all Services that require the exercise of professional skills or judgment are accomplished by professionals qualified and competent in the applicable discipline and appropriately licensed, if required by law. Contractor must provide copies of any such licenses. Contractor remains responsible for the professional and technical accuracy of all

Services or Deliverables furnished, whether by Contractor or its Subcontractors or others on its behalf. All Deliverables must be prepared in a form and content satisfactory to the Department and delivered in a timely manner consistent with the requirements of this Agreement.

If Contractor fails to comply with the foregoing standards, Contractor must perform again, at its own expense, all Services required to be re-performed as a direct or indirect result of that failure. Any review, approval, acceptance or payment for any of the Services by the County does not relieve Contractor of its responsibility for the professional skill and care and technical accuracy of its Services and Deliverables. This provision in no way limits the County's rights against Consultant either under this Agreement, at law or in equity.

d) Personnel

i) Adequate Staffing

Contractor must, upon receiving a fully executed copy of this Agreement, assign and maintain during the term of this Agreement and any extension of it an adequate staff of competent personnel that is fully equipped, licensed as appropriate, available as needed, qualified and assigned exclusively to perform the Services. Contractor must include among its staff the Key Personnel and positions as identified below. The level of staffing may be revised from time to time by notice in writing from Contractor to the County and with written consent of the County, which consent the County will not withhold unreasonably. If the County fails to object to the revision within 14 days after receiving the notice, then the revision will be considered accepted by the County.

ii) Key Personnel

Contractor must not reassign or replace Key Personnel without the written consent of the County, which consent the County will not unreasonably withhold. "Key Personnel" means those job titles and the persons assigned to those positions in accordance with the provisions of this Section 3.d (ii). The Department may at any time in writing notify Contractor that the County will no longer accept performance of Services under this Agreement by one or more Key Personnel listed. Upon that notice Contractor must immediately suspend the services of the key person or persons and must replace him or them in accordance with the terms of this Agreement. A list of Key Personnel is found in Exhibit 1, Scope of Services.

iii) Salaries and Wages

Contractor and Subcontractors must pay all salaries and wages due all employees performing Services under this Agreement unconditionally and at least once a month without deduction or rebate on any account, except only for those payroll deductions that are mandatory by law or are permitted under applicable law and regulations. If in the performance of this Agreement Contractor underpays any such salaries or wages, the Comptroller for the County may withhold, out of payments due to Contractor, an amount sufficient to pay to employees underpaid the

difference between the salaries or wages required to be paid under this Agreement and the salaries or wages actually paid these employees for the total number of hours worked. The amounts withheld may be disbursed by the Comptroller for and on account of Contractor to the respective employees to whom they are due. The parties acknowledge that this Section 3.d (iii) is solely for the benefit of the County and that it does not grant any third party beneficiary rights.

e) Minority and Women's Business Enterprises Commitment

In the performance of this Agreement, including the procurement and lease of materials or equipment, Contractor must abide by the minority and women's business enterprise commitment requirements of the Cook County Ordinance, (Article IV, Section 34-267 through 272) except to the extent waived by the Compliance Director. Contractor's completed MBE/WBE Utilization Plan evidencing its compliance with this requirement are a part of this Agreement, in Section 1 of the Economic Disclosure Statement, upon acceptance by the Compliance Director. Contractor must utilize minority and women's business enterprises at the greater of the amounts committed to by the Contractor for this Agreement in accordance with Section 1 of the Economic Disclosure Statement.

f) Insurance

Contractor must provide and maintain at Contractor's own expense, during the term of this Agreement and any time period following expiration if contractor is required to return and perform any of the Services or Additional Services under this Agreement, the insurance coverage's and requirements specified below, insuring all operations related to this Agreement.

i) Insurance to Be Provided

(1) Workers Compensation and Employers Liability

Workers Compensation Insurance, as prescribed by applicable law, covering all employees who are to provide a service under this Agreement and Employers Liability coverage with limits of not less than \$500,000 each accident or illness.

(2) Commercial General Liability (Primary and Umbrella)

Commercial General Liability Insurance or equivalent with limits of not less than \$2,000,000 per occurrence for bodily injury, personal injury and property damage liability. Coverage's must include the following: All premises and operations, products/completed operations, separation of insured, defense and contractual liability (with no limitation endorsement). Cook County is to be named as an additional insured on a primary, non-contributory basis for any liability arising directly or indirectly from the Services.

Subcontractors performing Services for Contractor must maintain limits of not less than \$1,000,000 with the same terms in this Section 3(f) (ii).

(3) Automobile Liability (Primary and Umbrella)

When any motor vehicles (owned, non-owned and hired) are used in connection with Services to be performed, Contractor must provide Automobile Liability Insurance with limits of not less than \$1,000,000 per occurrence limit, for bodily injury and property damage. The County is to be named as an additional insured on a primary, non-contributory basis.

(4) Professional Liability

When any professional contractor perform Services in connection with this Agreement, Professional Liability Insurance covering acts, errors or omissions must be maintained with limits of not less than \$2,000,000. Coverage must include contractual liability. When policies are renewed or replaced, the policy retroactive date must coincide with, or proceed, start of Services on this Agreement. A claims-made policy which is not renewed or replaced must have an extended reporting period of 2 years.

Subcontractors performing Services for Contractor must maintain limits of not less than \$1,000,000 with the same terms in this Section 3.

(5) Valuable Papers

When any designs, drawings, specifications and documents are produced or used under this Agreement, Valuable Papers Insurance must be maintained in an amount to insure against any loss whatsoever, and must have limits sufficient to pay for the re-creation and reconstruction of such records.

ii) **Additional Requirements**

(1) Contractor must furnish the County of Cook, Cook County, Office of the Chief Procurement Officer, 118 N. Clark St., Room 1018, Chicago, IL 60602, original Certificates of Insurance, or such similar evidence, to be in force on the date of this Agreement, and Renewal Certificates of Insurance, or such similar evidence, if the coverage's have an expiration or renewal date occurring during the term of this Agreement. Contractor must submit evidence of insurance on the County Insurance Certificate Form (copy attached as Exhibit 3) or equivalent prior to Agreement award. The receipt of any certificate does not constitute agreement by the County that the insurance requirements in this Agreement have been fully met or that the insurance policies indicated on the certificate are in compliance with all Agreement requirements. The failure of the County to obtain certificates or other insurance evidence from Contractor is not a waiver by the County of any requirements for Contractor to obtain and maintain the specified coverage's. Contractor must advise all insurers of the provisions in this Agreement regarding insurance. Non-conforming insurance does not relieve Contractor of the obligation to provide insurance as specified in this Agreement. Nonfulfillment of the insurance conditions may constitute a violation of this Agreement, and the County retains the right to

terminate this Agreement or to suspend this Agreement until proper evidence of insurance is provided.

(1) The insurance must provide for 60 days prior written notice to be given to the County in the event coverage is substantially changed, canceled or non-renewed. All deductibles or self-insured retentions on referenced insurance coverage's must be borne by Contractor. Contractor agrees that insurers waive their rights of subrogation against the County of Cook, its employees, elected officials, agents or representatives.

(2) The coverage's and limits furnished by Contractor in no way limit Contractor's liabilities and responsibilities specified within this Agreement or by law. Any insurance or self-insurance programs maintained by the County of Cook apply in excess of and do not contribute with insurance provided by Contractor under this Agreement.

(3) The required insurance is not limited by any limitations expressed in the indemnification language in this Agreement or any limitation placed on the indemnity in this Agreement given as a matter of law.

(4) Contractor must require all Subcontractors to provide the insurance required in this Agreement, or Contractor may provide the coverage's for Subcontractors. All Subcontractors are subject to the same insurance requirements as Contractor unless otherwise specified in this Agreement. If Contractor or Subcontractor desires additional coverage's, the party desiring the additional coverage's is responsible for its acquisition and cost.

(5) The County's Risk Management Office maintains the rights to modify, delete, alter or change these requirements. "**Risk Management Office**" means the Risk Management Office, which is under the direction of the Director of Risk Management and is charged with reviewing and analyzing insurance and related liability matters for the County.

g) Indemnification

The Contractor covenants and agrees to indemnify and save harmless the County and its commissioners, officials, employees, agents and representatives, and their respective heirs, successors and assigns, from and against any and all costs, expenses, attorney's fees, losses, damages and liabilities incurred or suffered directly or indirectly from or attributable to any claims arising out of or incident to the performance or nonperformance of the Contract by the Contractor, or the acts or omissions of the officers, agents, employees, contractors, subcontractors, licensees or invitees of the Contractor. The Contractor expressly understands and agrees that any Performance Bond or insurance protection required of the Contractor, or otherwise provided by the Contractor, shall in no way limit the responsibility to indemnify the County as hereinabove provided.

h) Confidentiality and Ownership of Documents

Contractor acknowledges and agrees that information regarding this Contract is confidential and shall not be disclosed, directly, indirectly or by implication, or be used by Contractor in any way, whether during the term of this Contract or at any time thereafter, except solely as required in the

course of Contractor's performance hereunder. Contractor shall comply with the applicable privacy laws and regulations affecting County and will not disclose any of County's records, materials, or other data to any third party. Contractor shall not have the right to compile and distribute statistical analyses and reports utilizing data derived from information or data obtained from County without the prior written approval of County. In the event such approval is given, any such reports published and distributed by Contractor shall be furnished to County without charge.

All documents, data, studies, reports, work product or product created as a result of the performance of the Contract (the "Documents") shall be included in the Deliverables and shall be the property of the County of Cook. It shall be a breach of this Contract for the Contractor to reproduce or use any documents, data, studies, reports, work product or product obtained from the County of Cook or any Documents created hereby, whether such reproduction or use is for Contractor's own purposes or for those of any third party. During the performance of the Contract Contractor shall be responsible of any loss or damage to the Documents while they are in Contractor's possession, and any such loss or damage shall be restored at the expense of the Contractor. The County and its designees shall be afforded full access to the Documents and the work at all times.

i) Patents, Copyrights and Licenses

If applicable, Contractor shall furnish the Chief Procurement Officer with all licenses required for the County to utilize any software, including firmware or middleware, provided by Contractor as part of the Deliverables. Such licenses shall be clearly marked with a reference to the number of this County Contract. Contractor shall also furnish a copy of such licenses to the Chief Procurement Officer. Unless otherwise stated in these Contract documents, such licenses shall be perpetual and shall not limit the number of persons who may utilize the software on behalf of the County.

Contractor agrees to hold harmless and indemnify the County, its officers, agents, employees and affiliates from and defend, at its own expense (including reasonable attorneys', accountants' and consultants' fees), any suit or proceeding brought against County based upon a claim that the ownership and/or use of equipment, hardware and software or any part thereof provided to the County or utilized in performing Contractor's services constitutes an infringement of any patent, copyright or license or any other property right.

In the event the use of any equipment, hardware or software or any part thereof is enjoined, Contractor with all reasonable speed and due diligence shall provide or otherwise secure for County, at the Contractor's election, one of the following: the right to continue use of the equipment, hardware or software; an equivalent system having the Specifications as provided in this Contract; or Contractor shall modify the system or its component parts so that they become non-infringing while performing in a substantially similar manner to the original system, meeting the requirements of this Contract.

j) Examination of Records and Audits

The Contractor agrees that the Cook County Auditor or any of its duly authorized representatives shall, until expiration of three (3) years after the final payment under the Contract, have access and the right to examine any books, documents, papers, canceled checks, bank statements, purveyor's and other invoices, and records of the Contractor related to the Contract, or to Contractor's compliance with any term, condition or provision thereof. The Contractor shall be responsible for establishing and maintaining records sufficient to document the costs associated with performance under the terms of this Contract.

The Contractor further agrees that it shall include in all of its subcontracts hereunder a provision to the effect that the subcontractor agrees that the Cook County Auditor or any of its duly authorized representatives shall, until expiration of three (3) years after final payment under the subcontract, have access and the right to examine any books, documents, papers, canceled checks, bank statements, purveyor's and other invoices and records of such subcontractor involving transactions relating to the subcontract, or to such subcontractor's compliance with any term, condition or provision thereunder or under the Contract.

In the event the Contractor receives payment under the Contract, reimbursement for which is later disallowed by the County, the Contractor shall promptly refund the disallowed amount to the County on request, or at the County's option, the County may credit the amount disallowed from the next payment due or to become due to the Contractor under any contract with the County.

To the extent this Contract pertains to Deliverables which may be reimbursable under the Medicaid or Medicare Programs, Contractor shall retain and make available upon request, for a period of four (4) years after furnishing services pursuant to this Agreement, the contract, books, documents and records which are necessary to certify the nature and extent of the costs of such services if requested by the Secretary of Health and Human Services or the Comptroller General of the United States or any of their duly authorized representatives. If Contractor carries out any of its duties under the Agreement through a subcontract with a related organization involving a value of cost of \$10,000.00 or more over a 12 month period, Contractor will cause such subcontract to contain a clause to the effect that, until the expiration of four years after the furnishing of any service pursuant to said subcontract, the related organization will make available upon request of the Secretary of Health and Human Services or the Comptroller General of the United States or any of their duly authorized representatives, copies of said subcontract and any books, documents, records and other data of said related organization that are necessary to certify the nature and extent of such costs. This paragraph relating to the retention and production of documents is included because of possible application of Section 1861(v) (1) (I) of the Social Security Act to this Agreement; if this Section should be found to be inapplicable, then this paragraph shall be deemed inoperative and without force and effect.

k) Subcontract Subcontracting or Assignment of Contract or Contract Funds

Once awarded, this Contract shall not be subcontracted or assigned, in whole or in part,

without the advance written approval of the Chief Procurement Officer, which approval shall be granted or withheld at the sole discretion of the Chief Procurement Officer. In no case, however, shall such approval relieve the Contractor from its obligations or change the terms of the Contract. The Contractor shall not transfer or assign any Contract funds or any interest therein due or to become due without the advance written approval of the Chief Procurement Officer. The unauthorized subcontracting or assignment of the Contract, in whole or in part, or the unauthorized transfer or assignment of any Contract funds, either in whole or in part, or any interest therein, which shall be due or are to become due the Contractor shall have no effect on the County and are null and void.

Prior to the commencement of the Contract, the Contractor shall identify in writing to the Chief Procurement Officer the names of any and all subcontractors it intends to use in the performance of the Contract. The Chief Procurement Officer shall have the right to disapprove any subcontractor. Identification of subcontractors to the Chief Procurement Officer shall be in addition to any communications with County offices other than the Chief Procurement Officer. All subcontractors shall be subject to the terms of this Contract. Contractor shall incorporate into all subcontracts all of the provisions of the Contract which affect such subcontract. Copies of subcontracts shall be provided to the Chief Procurement Officer upon request.

The Contractor must disclose the name and business address of each subcontractor, attorney, lobbyist, accountant, consultant and any other person or entity whom the Contractor has retained or expects to retain in connection with the Matter, as well as the nature of the relationship, and the total amount of the fees paid or estimated to be paid. The Contractor is not required to disclose employees who are paid or estimated to be paid. The Contractor is not required to disclose employees who are paid solely through the contractor's regular payroll. "Lobbyist" means any person or entity who undertakes to influence any legislation or administrative action on behalf of any person or entity other than: (1) a not-for-profit entity, on an unpaid basis, or (2), himself. "Lobbyist" also means any person or entity any part of whose duties as an employee of another includes undertaking to influence any legislative or administrative action. If the Contractor is uncertain whether a disclosure is required under this Section, the Contractor must either ask the County, whether disclosure is required or make the disclosure.

The County reserves the right to prohibit any person from entering any County facility for any reason. All contractors and subcontractors of the Contractor shall be accountable to the Chief Procurement Officer or his designee while on any County property and shall abide by all rules and regulations imposed by the County.

ARTICLE 4) TERM OF PERFORMANCE

a) Term of Performance

This Agreement takes effect on MARCH 1, 2013 ("Effective Date") and continues for three years through FEBRUARY 28, 2016 until this Agreement is terminated in accordance with its terms, whichever occurs first.

b) Agreement Extension Option

The Chief Procurement Officer may at any time before this Agreement expires elect to extend this Agreement for up to **two (2) one-year extensions** under the same terms and conditions as this original Agreement, except as provided otherwise in this Agreement, by notice in writing to Consultant. After notification by the Chief Procurement Officer, this Agreement must be modified to reflect the time extension in accordance with the provisions of Section 10.c.

c) Timeliness of Performance

i) Contractor must provide the Services and Deliverables within the term and within the time limits required under this Agreement, pursuant to the provisions of Section 4.a and Exhibit 1. Further, Contractor acknowledges that **TIME IS OF THE ESSENCE** and that the failure of Contractor to comply with the time limits described in this Section 4.2 may result in economic or other losses to the County.

ii) Neither Contractor nor Contractor's agents, employees or Subcontractors are entitled to any damages from the County, nor is any party entitled to be reimbursed by the County, for damages, charges or other losses or expenses incurred by Contractor by reason of delays or hindrances in the performance of the Services, whether or not caused by the County.

ARTICLE 5) COMPENSATION

a) Basis of Payment

The County will pay Contractor according to the Schedule of Compensation in the attached Exhibit 2 for the successful completion of services.

b) Method of Payment

All invoices submitted by the Contractor shall be in accordance with the cost provisions according to the Schedule of Compensation in the attached Exhibit 2. The invoices shall contain a detailed description of the Deliverables for which payment is requested. All invoices shall reflect the amounts invoiced by and the amounts paid to the Contractor as of the date of the invoice, and shall be submitted together with a properly completed County Voucher form (29A). Invoices for new charges shall not include "past due" amounts, if any, which amounts must be set forth on a separate invoice. No payments shall be made with respect to invoices which do not include the County Voucher form or which otherwise fail to comply with the requirements of this paragraph. Contractor shall not be entitled to invoice the County for any late fees or other penalties.

c) Funding

The source of funds for payments under this Agreement is identified in Exhibit 2, Schedule of Compensation. Payments under this Agreement must not exceed the dollar amount shown in Exhibit 2 without a written amendment in accordance with Section 10.c.

d) Non-Appropriation

If no funds or insufficient funds are appropriated and budgeted in any fiscal period of the County for payments to be made under this Agreement, then the County will notify Contractor in writing of that occurrence, and this Agreement will terminate on the earlier of the last day of the fiscal period for which sufficient appropriation was made or whenever the funds appropriated for payment under this Agreement are exhausted. Payments for Services completed to the date of notification will be made to Contractor. No payments will be made or due to Contractor and under this Agreement beyond those amounts appropriated and budgeted by the County to fund payments under this Agreement.

e) Taxes

Federal Excise Tax does not apply to materials purchased by the County by virtue of Exemption Certificate No. 36-75-0038K. Illinois Retailers' Occupation Tax, Use Tax and Municipal Retailers' Occupation Tax do not apply to deliverables, materials or services purchased by the County by virtue of statute. The price or prices quoted herein shall include any and all other federal and/or state, direct and/or indirect taxes which apply to this Contract. The County's State of Illinois Sales Tax Exemption Identification No. is E-9998-2013-05.

f) Price Reduction

If at any time after the contract award, Contractor makes a general price reduction in the price of any of the Deliverables, the equivalent price reduction based on similar quantities and/or considerations shall apply to this Contract for the duration of the Contract period. For purposes of this Section 5.f., Price Reduction, a general price reduction shall include reductions in the effective price charged by Contractor by reason of rebates, financial incentives, discounts, value points or other benefits with respect to the purchase of the Deliverables. Such price reductions shall be effective at the same time and in the same manner as the reduction Contractor makes in the price of the Deliverables to its prospective customers generally.

g) Contractor Credits

To the extent the Contractor gives credits toward future purchases of goods or services, financial incentives, discounts, value points or other benefits based on the purchase of the materials

or services provided for under this Contract, such credits belong to the County and not any specific using department. Contractor shall reflect any such credits on its invoices and in the amounts it invoices the County.

ARTICLE 6) DISPUTES

Any dispute arising under the Contract between the County and Contractor shall be decided by the Chief Procurement Officer. The complaining party shall submit a written statement detailing the dispute and specifying the specific relevant Contract provision(s) to the Chief Procurement Officer. Upon request of the Chief Procurement Officer, the party complained against shall respond to the complaint in writing within five days of such request. The Chief Procurement Officer will reduce her decision to writing and mail or otherwise furnish a copy thereof to the Contractor. The decision of the Chief Procurement Officer will be final and binding. Dispute resolution as provided herein shall be a condition precedent to any other action at law or in equity. However, unless a notice is issued by the Chief Procurement Officer indicating that additional time is required to review a dispute, the parties may exercise their contractual remedies, if any, if no decision is made within sixty (60) days following notification to the Chief Procurement Officer of a dispute. No inference shall be drawn from the absence of a decision by the Chief Procurement Officer. Notwithstanding a dispute, Contractor shall continue to discharge all its obligations, duties and responsibilities set forth in the Contract during any dispute resolution proceeding unless otherwise agreed to by the County in writing.

ARTICLE 7) COMPLIANCE WITH ALL LAWS

The Contractor shall observe and comply with the laws, ordinances, regulations and codes of the Federal, State, County and other local government agencies which may in any manner affect the performance of the Contract including, but not limited to, those County Ordinances set forth in the Certifications attached hereto and incorporated herein. Assurance of compliance with this requirement by the Contractor's employees, agents or subcontractors shall be the responsibility of the Contractor.

The Contractor shall secure and pay for all federal, state and local licenses, permits and fees required hereunder.

ARTICLE 8) SPECIAL CONDITIONS

a) Warranties and Representations

In connection with signing and carrying out this Agreement, Consultant:

- i) warrants that Contractor is appropriately licensed under Illinois law to perform the Services required under this Agreement and will perform no Services for which a professional license is required by law and for which Contractor is not appropriately licensed;
- ii) warrants it is financially solvent; it and each of its employees, agents and Subcontractors of any tier are competent to perform the Services required under this Agreement; and Contractor is legally authorized to execute and perform or cause to be performed this Agreement under the terms and conditions stated in this Agreement;
- iii) warrants that it will not knowingly use the services of any ineligible consultant or Subcontractor for any purpose in the performance of its Services under this Agreement;
- iv) warrants that Contractor and its Subcontractors are not in default at the time this Agreement is signed, and have not been considered by the Chief Procurement Officer to have, within 5 years immediately preceding the date of this Agreement, been found to be in default on any contract awarded by the County ;
- v) represents that it has carefully examined and analyzed the provisions and requirements of this Agreement; it understands the nature of the Services required; from its own analysis it has satisfied itself as to the nature of all things needed for the performance of this Agreement; this Agreement is feasible of performance in accordance with all of its provisions and requirements, and Contractor warrants it can and will perform, or cause to be performed, the Services in strict accordance with the provisions and requirements of this Agreement;
- vi) represents that Contractor and, to the best of its knowledge, its Subcontractors are not in violation of the provisions of the Illinois Criminal Code, 720 ILCS 5/33E as amended, and the Illinois Municipal Code, 65 ILCS 5/11-42.1-1; and
- vii) acknowledges that any certification, affidavit or acknowledgment made under oath in connection with this Agreement is made under penalty of perjury and, if false, is also cause for termination under Sections 9.A and 9.C.

b) Ethics

- i) In addition to the foregoing warranties and representations, Contractor warrants:
 - (1) no officer, agent or employee of the County is employed by Contractor or has a financial interest directly or indirectly in this Agreement or the compensation to be paid under this Agreement except as may be permitted in writing by the Board of Ethics.
 - (2) no payment, gratuity or offer of employment will be made in connection with this Agreement by or on behalf of any Subcontractors to the prime Contractor or higher tier

Subcontractors or anyone associated with them, as an inducement for the award of a subcontract or order.

c) Joint and Several Liability

If Contractor, or its successors or assigns, if any, is comprised of more than one individual or other legal entity (or a combination of them), then under this Agreement, each and without limitation every obligation or undertaking in this Agreement to be fulfilled or performed by Contractor is the joint and several obligation or undertaking of each such individual or other legal entity.

d) Business Documents

At the request of the County, Contractor must provide copies of its latest articles of incorporation, by-laws and resolutions, or partnership or joint venture agreement, as applicable.

e) Conflicts of Interest

i) No member of the governing body of the County or other unit of government and no other officer, employee or agent of the County or other unit of government who exercises any functions or responsibilities in connection with the Services to which this Agreement pertains is permitted to have any personal interest, direct or indirect, in this Agreement. No member of or delegate to the Congress of the United States or the Illinois General Assembly and no Commissioner of the Cook County Board or County employee is allowed to be admitted to any share or part of this Agreement or to any financial benefit to arise from it.

ii) Contractor covenants that it, and to the best of its knowledge, its Subcontractors if any (collectively, "**Contracting Parties**"), presently have no direct or indirect interest and will not acquire any interest, direct or indirect, in any project or contract that would conflict in any manner or degree with the performance of its Services under this Agreement.

iii) Upon the request of the County, Contractor must disclose to the County its past client list and the names of any clients with whom it has an ongoing relationship. Contractor is not permitted to perform any Services for the County on applications or other documents submitted to the County by any of Contractor's past or present clients. If Contractor becomes aware of a conflict, it must immediately stop work on the assignment causing the conflict and notify the County.

iv) Without limiting the foregoing, if the Contracting Parties assist the County in determining the advisability or feasibility of a project or in recommending, researching, preparing, drafting or issuing a request for proposals or bid specifications for a project, the Contracting Parties must not participate, directly or indirectly, as a prime, subcontractor or joint venturer in that project or in the preparation of a proposal or bid for that project during the term of this Agreement or afterwards. The Contracting Parties may, however, assist the County in

reviewing the proposals or bids for the project if none of the Contracting Parties have a relationship with the persons or entities that submitted the proposals or bids for that project.

v) The Contractor further covenants that, in the performance of this Agreement, no person having any conflicting interest will be assigned to perform any Services or have access to any confidential information, as defined in Section 3.11 of this Agreement. If the County, by the Chief Procurement Officer in his reasonable judgment, determines that any of Contractor's Services for others conflict with the Services Contractor is to render for the County under this Agreement, Contractor must terminate such other services immediately upon request of the County.

vi) Furthermore, if any federal funds are to be used to compensate or reimburse Contractor under this Agreement, Consultant represents that it is and will remain in compliance with federal restrictions on lobbying set forth in Section 319 of the Department of the Interior and Related Agencies Appropriations Act for Fiscal year 1990, 31 U.S.C. § 1352, and related rules and regulations set forth at 54 Fed. Reg. 52,309 ff. (1989), as amended. If federal funds are to be used, Contractor must execute a Certification Regarding Lobbying, which will be attached as an exhibit and incorporated by reference as if fully set forth here.

f) Non-Liability of Public Officials

Contractor and any assignee or Subcontractor of Contractor must not charge any official, employee or agent of the County personally with any liability or expenses of defense or hold any official, employee or agent of the County personally liable to them under any term or provision of this Agreement or because of the County's execution, attempted execution or any breach of this Agreement.

ARTICLE 9) EVENTS OF DEFAULT, REMEDIES, TERMINATION, SUSPENSION AND RIGHT TO OFFSET

a) Events of Default Defined

The following constitute events of default:

i) Any material misrepresentation, whether negligent or willful and whether in the inducement or in the performance, made by Contractor to the County.

ii) Contractor's material failure to perform any of its obligations under this Agreement including the following:

(a) Failure due to a reason or circumstances within Contractor's reasonable control to perform the Services with sufficient personnel and equipment or with sufficient material to ensure the performance of the Services;

- (b) Failure to perform the Services in a manner reasonably satisfactory to the Chief Procurement Officer or inability to perform the Services satisfactorily as a result of insolvency, filing for bankruptcy or assignment for the benefit of creditors;
 - (c) Failure to promptly re-perform within a reasonable time Services that were rejected as erroneous or unsatisfactory;
 - (d) Discontinuance of the Services for reasons within Contractor's reasonable control; and
 - (e) Failure to comply with any other material term of this Agreement, including the provisions concerning insurance and nondiscrimination.
- iii) Any change in ownership or control of Contractor without the prior written approval of the Chief Procurement Officer, which approval the Chief Procurement Officer will not unreasonably withhold.
 - iv) Contractor's default under any other agreement it may presently have or may enter into with the County during the life of this Agreement. Contractor acknowledges and agrees that in the event of a default under this Agreement the County may also declare a default under any such other Agreements.
 - (v) Failure to comply with Section 7 in the performance of the Agreement.
 - (vi) Contractor's repeated or continued violations of County ordinances unrelated to performance under the Agreement that in the opinion of the Chief Procurement Officer indicate a willful or reckless disregard for County laws and regulations.

b) Remedies

The occurrence of any event of default permits the County, at the County's sole option, to declare Contractor in default. The Chief Procurement Officer may in his sole discretion give Contractor an opportunity to cure the default within a certain period of time, which period of time must not exceed 30 days, unless extended by the Chief Procurement Officer. Whether to declare Contractor in default is within the sole discretion of the Chief Procurement Officer and neither that decision nor the factual basis for it is subject to review or challenge under the Disputes provision of this Agreement.

The Chief Procurement Officer will give Contractor written notice of the default, either in the form of a cure notice ("**Cure Notice**"), or, if no opportunity to cure will be granted, a default notice ("**Default Notice**"). If the Chief Procurement Officer gives a Default Notice, he will also indicate any present intent he may have to terminate this Agreement, and the decision to terminate (but not the decision not to terminate) is final and effective upon giving the notice.

The Chief Procurement Officer may give a Default Notice if Contractor fails to effect a cure within the cure period given in a Cure Notice. When a Default Notice with intent to terminate is given as provided in this Section 9.b and Article 11, Contractor must discontinue any Services, unless otherwise directed in the notice, and deliver all materials accumulated in the performance of this Agreement, whether completed or in the process, to the County. After giving a Default Notice, the County may invoke any or all of the following remedies:

- i) The right to take over and complete the Services, or any part of them, at Contractor's expense and as agent for Contractor, either directly or through others, and bill Contractor for the cost of the Services, and Contractor must pay the difference between the total amount of this bill and the amount the County would have paid Contractor under the terms and conditions of this Agreement for the Services that were assumed by the County as agent for the Contractor under this Section 9.2;
- ii) The right to terminate this Agreement as to any or all of the Services yet to be performed effective at a time specified by the County;
- iii) The right of specific performance, an injunction or any other appropriate equitable remedy;
- iv) The right to money damages;
- v) The right to withhold all or any part of Contractor's compensation under this Agreement;
- vi) The right to consider Contractor non-responsible in future contracts to be awarded by the County.

If the Chief Procurement Officer considers it to be in the County's best interests, he may elect not to declare default or to terminate this Agreement. The parties acknowledge that this provision is solely for the benefit of the County and that if the County permits Contractor to continue to provide the Services despite one or more events of default, Contractor is in no way relieved of any of its responsibilities, duties or obligations under this Agreement, nor does the County waive or relinquish any of its rights.

The remedies under the terms of this Agreement are not intended to be exclusive of any other remedies provided, but each and every such remedy is cumulative and is in addition to any other remedies, existing now or later, at law, in equity or by statute. No delay or omission to exercise any right or power accruing upon any event of default impairs any such right or power, nor is it a waiver of any event of default nor acquiescence in it, and every such right and power may be exercised from time to time and as often as the County considers expedient.

c) Early Termination

In addition to termination under Sections 9.a and 9.b of this Agreement, the County may terminate this Agreement, or all or any portion of the Services to be performed under it, at any time by a notice in writing from the County to Contractor. The County will give notice to Contractor in accordance with the provisions of Article 11. The effective date of termination will be the date the notice is received by Contractor or the date stated in the notice, whichever is later. If the County elects to terminate this Agreement in full, all Services to be provided under it must cease and all materials that may have been accumulated in performing this Agreement, whether completed or in the process, must be delivered to the County effective 10 days after the date the notice is considered received as provided under Article 11 of this Agreement (if no date is given) or upon the effective date stated in the notice.

After the notice is received, Contractor must restrict its activities, and those of its Subcontractors, to winding down any reports, analyses, or other activities previously begun. No costs incurred after the effective date of the termination are allowed. Payment for any Services actually and satisfactorily performed before the effective date of the termination is on the same basis as set forth in Article 5, but if any compensation is described or provided for on the basis of a period longer than 10 days, then the compensation must be prorated accordingly. No amount of compensation, however, is permitted for anticipated profits on unperformed Services. The County and Consultant must attempt to agree on the amount of compensation to be paid to Contractor, but if not agreed on, the dispute must be settled in accordance with Article 6 of this Agreement. The payment so made to Contractor is in full settlement for all Services satisfactorily performed under this Agreement.

Contractor must include in its contracts with Subcontractors an early termination provision in form and substance equivalent to this early termination provision to prevent claims against the County arising from termination of subcontracts after the early termination. Contractor will not be entitled to make any early termination claims against the County resulting from any Subcontractor's claims against Contractor or the County to the extent inconsistent with this provision.

If the County's election to terminate this Agreement for default under Sections 9.a and 9.b is determined in a court of competent jurisdiction to have been wrongful, then in that case the termination is to be considered to be an early termination under this Section 9.c.

d) Suspension

The County may at any time request that Contractor suspend its Services, or any part of them, by giving 15 days prior written notice to Contractor or upon informal oral, or even no notice, in the event of emergency. No costs incurred after the effective date of such suspension are allowed. Contractor must promptly resume its performance of the Services under the same terms and conditions as stated in this Agreement upon written notice by the Chief Procurement Officer and such equitable extension of time as may be mutually agreed upon by the Chief Procurement Officer and Contractor when necessary for continuation or completion of Services. Any additional costs or expenses actually incurred by Contractor as a result of recommencing the

Services must be treated in accordance with the compensation provisions under Article 5 of this Agreement.

No suspension of this Agreement is permitted in the aggregate to exceed a period of 45 days within any one year of this Agreement. If the total number of days of suspension exceeds 45 days, Contractor by written notice may treat the suspension as an early termination of this Agreement under Section 9.c.

e) Right to Offset

i) In connection with performance under this Agreement:

The County may offset any excess costs incurred:

(i) if the County terminates this Agreement for default or any other reason resulting from Contractor's performance or non-performance;

(ii) if the County exercises any of its remedies under Section 9.2 of this Agreement; or

(iii) if the County has any credits due or has made any overpayments under this Agreement.

The County may offset these excess costs by use of any payment due for Services completed before the County terminated this Agreement or before the County exercised any remedies. If the amount offset is insufficient to cover those excess costs, Contractor is liable for and must promptly remit to the County the balance upon written demand for it. This right to offset is in addition to and not a limitation of any other remedies available to the County.

f.) Delays

Contractor agrees that no charges or claims for damages shall be made by Contractor for any delays or hindrances from any cause whatsoever during the progress of any portion of this Contract.

g.) Prepaid Fees

In the event this Contract is terminated by either party, for cause or otherwise, and the County has prepaid for any Deliverables, Contractor shall refund to the County, on a prorated basis to the effective date of termination, all amounts prepaid for Deliverables not actually provided as of the effective date of the termination. The refund shall be made within fourteen (14) days of the

effective date of termination.

ARTICLE 10) GENERAL CONDITIONS

a) Entire Agreement

i) General

This Agreement, and the exhibits attached to it and incorporated in it, constitute the entire agreement between the parties and no other warranties, inducements, considerations, promises or interpretations are implied or impressed upon this Agreement that are not expressly addressed in this Agreement.

ii) No Collateral Agreements

Contractor acknowledges that, except only for those representations, statements or promises expressly contained in this Agreement and any exhibits attached to it and incorporated by reference in it, no representation, statement or promise, oral or in writing, of any kind whatsoever, by the County, its officials, agents or employees, has induced Contractor to enter into this Agreement or has been relied upon by Contractor, including any with reference to: (i) the meaning, correctness, suitability or completeness of any provisions or requirements of this Agreement; (ii) the nature of the Services to be performed; (iii) the nature, quantity, quality or volume of any materials, equipment, labor and other facilities needed for the performance of this Agreement; (iv) the general conditions which may in any way affect this Agreement or its performance; (v) the compensation provisions of this Agreement; or (vi) any other matters, whether similar to or different from those referred to in (i) through (vi) immediately above, affecting or having any connection with this Agreement, its negotiation, any discussions of its performance or those employed or connected or concerned with it.

iii) No Omissions

Contractor acknowledges that Contractor was given an opportunity to review all documents forming this Agreement before signing this Agreement in order that it might request inclusion in this Agreement of any statement, representation, promise or provision that it desired or on that it wished to place reliance. Contractor did so review those documents, and either every such statement, representation, promise or provision has been included in this Agreement or else, if omitted, Contractor relinquishes the benefit of any such omitted statement, representation, promise or provision and is willing to perform this Agreement in its entirety without claiming reliance on it or making any other claim on account of its omission.

b) Counterparts

This Agreement is comprised of several identical counterparts, each to be fully signed by the parties and each to be considered an original having identical legal effect.

c) Modifications and Amendments

The parties may from time to time during the term of the Contract make modifications and amendments to the Contract but only as provided in this section. Such modifications and amendments shall only be made by mutual agreement in writing. Modifications and amendments which individually or cumulatively result in additional cost of \$1,000.00 or greater or which extend the term of the Contract by thirty (30) days or more shall not be deemed as authorized without the approval of the Cook County Board of Commissioners. Modifications and amendments which increase cost by less than \$1,000.00 or which do not extend the term of the Contract by more than thirty (30) days may only be made with the written approval of the Chief Procurement Officer.

Subject to the foregoing, the Chief Procurement Officer may, by written order, make changes with respect to the dates of delivery and places of performance of the Contract, provided that any such changes shall not increase the Contract price or the time required for Contract performance.

Contractor is hereby notified that, except for modifications and amendments which are made in accordance with this Section 10.c., Modifications and Amendments, no County department or employee thereof has authority to make any modification or amendment to this Contract.

d) Governing Law and Jurisdiction

This Contract shall be governed by and construed under the laws of the State of Illinois. The Contractor irrevocably agrees that, subject to the County's sole and absolute election to the contrary, any action or proceeding in any way, manner or respect arising out of the Contract, or arising from any dispute or controversy arising in connection with or related to the Contract, shall be litigated only in courts within the Circuit Court of Cook County, State of Illinois, and the Contractor consents and submits to the jurisdiction thereof. In accordance with these provisions, Contractor waives any right it may have to transfer or change the venue of any litigation brought against it by the County pursuant to this Contract.

e) Severability

If any provision of this Agreement is held or considered to be or is in fact invalid, illegal, inoperative or unenforceable as applied in any particular case in any jurisdiction or in all cases because it conflicts with any other provision or provisions of this Agreement or of any constitution, statute, ordinance, rule of law or public policy, or for any other reason, those circumstances do not have the effect of rendering the provision in question invalid, illegal, inoperative or unenforceable in any other case or circumstances, or of rendering any other provision or provisions in this Agreement invalid, illegal, inoperative or unenforceable to any extent whatsoever. The invalidity, illegality, inoperativeness or unenforceability of any one or

more phrases, sentences, clauses or sections in this Agreement does not affect the remaining portions of this Agreement or any part of it.

f) Assigns

All of the terms and conditions of this Agreement are binding upon and inure to the benefit of the parties and their respective legal representatives, successors and assigns.

g) Cooperation

Contractor must at all times cooperate fully with the County and act in the County's best interests. If this Agreement is terminated for any reason, or if it is to expire on its own terms, Contractor must make every effort to assure an orderly transition to another provider of the Services, if any, orderly demobilization of its own operations in connection with the Services, uninterrupted provision of Services during any transition period and must otherwise comply with the reasonable requests and requirements of the Department in connection with the termination or expiration.

h) Waiver

Nothing in this Agreement authorizes the waiver of a requirement or condition contrary to law or ordinance or that would result in or promote the violation of any federal, state or local law or ordinance.

Whenever under this Agreement the County by a proper authority waives Contractor's performance in any respect or waives a requirement or condition to either the County's or Contractor's performance, the waiver so granted, whether express or implied, only applies to the particular instance and is not a waiver forever or for subsequent instances of the performance, requirement or condition. No such waiver is a modification of this Agreement regardless of the number of times the County may have waived the performance, requirement or condition. Such waivers must be provided to Contractor in writing.

i) Independent Contractor

This Agreement is not intended to and will not constitute, create, give rise to, or otherwise recognize a joint venture, partnership, corporation or other formal business association or organization of any kind between Contractor and the County. The rights and the obligations of the parties are only those expressly set forth in this Agreement. Contractor must perform under this Agreement as an independent contractor and not as a representative, employee, agent, or partner of the County.

This Agreement is between the County and an independent contractor and, if Contractor is an individual, nothing provided for under this Agreement constitutes or implies an employer-employee relationship such that:

i) The County will not be liable under or by reason of this Agreement for the payment of any compensation award or damages in connection with the Contractor performing the Services required under this Agreement.

ii) Contractor is not entitled to membership in the County Pension Fund, Group Medical Insurance Program, Group Dental Program, Group Vision Care, Group Life Insurance Program, Deferred Income Program, vacation, sick leave, extended sick leave, or any other benefits ordinarily provided to individuals employed and paid through the regular payrolls of the County.

iii) The County is not required to deduct or withhold any taxes, FICA or other deductions from any compensation provided to the Contractor.

j) Governmental Joint Purchasing Agreement







Scope of Services

SCOPE OF SERVICES for Sentinel

Part 1: Adult Probation Department

I. USING DEPARTMENT BACKGROUND INFORMATION

The Circuit Court of Cook County Adult Probation Department is a department within the County of Cook and operates under the Office of the Chief Judge. The majority of the Department's resources are dedicated to supervising criminal offenders sentenced to probation, which is a sentencing option that requires offenders to comply with specific conditions while residing in the community. Probation officers assist offenders in complying with their sentences through guidance, surveillance, and referrals to service providers for treatment, education, and employment services. The department's Home Confinement Unit monitors curfews on probation and pretrial cases through field visits and telephone calls. Through its pretrial services units, Adult Probation supervises defendants released on bond and conducts pre-bail interviews to assist the courts in making decisions about bond/pretrial supervision. About 88% of the department's caseload is composed of felons and 12% of misdemeanants. While most probationers are assigned to standard caseload supervision, about 12% are supervised in specialized programs designed for specific offender populations. These include the Adult Sex Offender Program, the Domestic Violence Intervention Unit, the Mental Health Unit, the Gang Intervention Unit, Intensive Probation Supervision, the Intensive Drug Program, Cook County's drug treatment courts, and the POWER Program (Promotion of Women through Education and Resources).

II. CURRENT SOLUTION / METHOD

The Cook County Adult Probation Department has a current utilization rate of approximately 70 units for offenders and 70 units for victims (~140 total in service). The department leases the GPS enabled Omni Link OM 210. Usage rates are approximate as they are dependent on court orders.

III. REQUIREMENTS

A. Overview

The Contractor shall provide equipment and services for an offender tracking system that utilizes active global positioning system (GPS) technology and other appropriate technology to ensure that offenders are actively monitored 24 hours per day, 7 days per week. Most individuals requiring GPS monitoring will be domestic violence offenders who have been charged with or convicted of violating an order of protection and who have been court ordered to be placed in an electronic surveillance program that utilizes GPS.

Given the changing nature of our managed population, it is difficult to know how many offenders will be required to be monitored, though it is roughly estimated that the Department will need equipment and services for between 150 and 400 GPS units.

B. General System Requirements

1. The tracking system shall be capable of identifying all alerts in near-real time 24 hours per day, seven days per week and of notifying immediately the appropriate parties including law enforcement, the victim, and the Department.
2. The Contractor must initially provide 150 active GPS units and be capable of providing up to 400 (approximately 350) active units.
3. The Contractor shall be able to fulfill requests for additional units within 24 hours upon request of the Department.
4. The system shall be capable of providing immediate GPS alert information to law enforcement and the victim via live telephone operator, automated voice notification, and text message.
5. The system shall be capable of providing immediate Department alert notification via telephone and email.
6. The system shall allow voice and text communication with the offender.
7. The system shall immediately generate an alert that is specifically identified by type (e.g., exclusion zone alert, inclusion zone alert, tamper alert, low-battery alert, etc.) in the event of any of the following related to GPS alerts:
 - i. the receiver or bracelet strap has been tampered with;
 - ii. the device is no longer tracking (e.g., no GPS signal);
 - iii. the GPS receiver battery is low
 - iv. the GPS receiver battery is dead;
 - v. the GPS receiver is not charged according to a predefined schedule;
 - vi. the GPS receiver is unable to communicate with the Contractor's monitoring software due to a communications failure (e.g., when the system cannot send data due to problems with cell communications);
 - vii. the system detects a zone infraction (e.g., exclusion, inclusion, and mobile);
 - viii. the GPS receiver is in motion but is not being tracked by GPS;
 - ix. the equipment malfunctions in any other manner not specified above.
8. The central host system, the repository of all monitoring data, shall not be located in the Department's facility and shall be the responsibility of the Contractor.
9. The system must be capable of operating in primarily urban and suburban environments.
10. GPS equipment must be capable of detecting location accuracy within 100 feet.

11. GPS equipment shall utilize a supplemental or an enhanced tracking system when GPS is unavailable or diminished.

C. Device/Hardware requirements

1. Device components shall comply with applicable Federal Communications Commission (FCC) regulations and shall be registered with the FCC.
2. The GPS receiver shall be capable of communicating with the U.S. Government Global Positioning System.
3. Units must be capable of operating normally when in proximity to other GPS/RF receivers and electronic devices (e.g., cell phones, satellite television receivers, microwave ovens, computers, and radio towers).
4. Units shall be capable of collecting and transmitting location data as frequently as once every minute. Some individuals under GPS monitoring may require less frequent collection and transmission rates.
5. Units shall have an internal clock and include the date and time of all recorded events.
6. Units shall be capable of recording and storing a minimum of 1-2 days of location data in the event of a communication disruption with the central host system (e.g., power outage, no cellular coverage). The unit shall transmit stored data to the monitoring center as soon as communication is restored and all alerts shall be specified and responded to appropriately.
7. The GPS receiver shall have an initial signal acquisition time of no more than 10 minutes.
8. The units shall not pose a safety hazard to the offender or others.
9. Device components shall be tamper resistant and the bracelet component should be tamper evident such that any attempt to remove it will leave physical evidence of the attempt.
10. Device components shall reliably function in environmental and atmospheric conditions that will normally be encountered.
11. Device components shall be capable of enduring shock and vibration associated with normal wear and use.
12. Device components which are physically attached to the offender shall be moisture and water resistant for such normal activities as bathing, showering, swimming, and sweating.

13. The monitoring unit shall have internal diagnostics that can determine if it is operating properly and it must have the ability to relay this information to the central monitoring center.
14. Each unit's receiver signal shall be unique to the individual to whom it is assigned.
15. The bracelet component shall be hypoallergenic.
16. The GPS receiver shall contain rechargeable batteries.
17. Battery operated components shall have a minimum battery life of 1 year before requiring replacement.
18. The GPS receiver shall continue to receive and transmit location data while it is being charged.
19. The GPS receiver should be fully charged within 2 hours.
20. The GPS receiver should emit a warning when the battery charge is low.
21. The GPS receiver must retain stored data when the battery is depleted.
22. The GPS receiver should be capable of operating for a minimum of 15 hours on a single battery charge when operating at the maximum levels of location point collection and transmission.
23. The unit should emit a low-battery life warning in enough time to replace the battery.
24. Device components that physically attach to the offender must be able to fit to any size individual. The size and weight should be comfortable, portable, and not interfere with normal activities or those related to manual labor jobs such as construction.

D. Software Requirements

1. The Contractor's central host system and software system shall be accessible to the Department via the Internet through a standard web browser interface. Access should accommodate up to 125 simultaneous users designated by the Department.
2. The system shall track and display offender information including but not limited to the following: name, case number, date of birth, fingerprint identification numbers (local, state, and/or federal), criminal charge information, home and work addresses, telephone number(s), physical descriptors (e.g., race, sex, height, and weight); the assigned supervision officer(s); assigned device(s); zones; alert and notification protocols; current monitoring status and tracking history. Also, the software system should provide the ability to store the offender's photo and information about the offender's vehicle(s).

3. The system shall track and display relevant information about the victim where applicable.
4. The software system shall display the physical location of the GPS-monitored offender on a user-friendly interactive map containing recognizable state, county, municipality, and street names. Every GPS point recorded shall be displayed and the time along with the direction and speed of travel indicated. The system should provide the ability to conduct a reverse geocode search in which a known location data point is used to look up the nearest physical address.
5. The software system shall, for GPS-monitored offenders, provide the ability to establish and edit exclusion zones and inclusion zones and should have the ability to establish and edit mobile zones, travel zones, and jurisdictional zones and if beneficial, buffer zones.
6. The software system shall provide the ability to configure multiple schedules for a single offender (e.g., weekday and weekend schedules).
7. The software system shall provide the ability to establish zones for individual GPS-monitored offenders and for groups of GPS-monitored offenders.
8. The software system should be able to create polygon shaped zones for GPS-monitored offenders.
9. The software system shall provide the ability to configure alert protocols that are unique to each offender and to configure alert protocols for certain groups of offenders.
10. The software system shall have the ability to display the status and history of the alerts identified in the previous section, "General System Requirements."
11. The software system shall provide the ability to view and manage the equipment inventory applicable to the Department.
12. The software system shall provide the ability to print maps of GPS-monitored offenders' location points that indicate the time and direction of travel.
13. The software system shall provide the ability to generate offender specific location reports, inventory reports, and management reports. The system shall have the ability to query, sort, and search by any field.

E. Data and System Security Requirements

1. Each authorized user must be able to access the Contractor's software in a secure manner.

2. The Department's data that is stored in the Contractor's software must be protected to ensure unauthorized access.
3. Contractor must have sound procedures (e.g., background checks, hiring practices, etc.) for ensuring its employees are properly authorized for access to confidential and sensitive offender information. The Contractor shall ensure that the confidentiality of offender records is maintained and shall not disclose any such information to any third party without written authorization of the Department.
4. The Contractor should be able to create user groups with varying access privileges (e.g., read/write and read only).
5. Each offender's location data shall be accessible for a minimum of 18 months before it is archived or stored offline.
6. Archived copies of each offender's location data shall be retained for a minimum of 5 years and/or provided in a format that can be stored and easily interpreted by the Department.
7. The Contractor shall backup the system data at least every 24 hours.
8. Data generated as a result of the location monitoring shall be owned by the Department and may not be used in any way by the Contractor without consent of the Department. The Contractor shall ensure that all data is available to the Department in the event the contract is terminated or the Contractor goes out of business.

F. Service Requirements

1. The Contractor's monitoring center shall be capable of providing services 24 hours a day, 7 days a week.
2. The Contractor's monitoring center shall be capable of conducting alert analysis and resolution using Department defined protocols, which will include notifying the Department of all alerts and notifying law-enforcement and the victim for certain types of alerts related to GPS monitoring of domestic violence offenders (e.g., exclusion zone violations). Alert analysis and resolution must begin immediately upon receiving an alert and must be completed promptly. For all domestic violence offenders on GPS monitoring and any other offenders designated by the Department, the Contractor shall use live phone operators to notify the victim and the appropriate law-enforcement agency of certain alerts. Currently, the Department works with over 120 local law-enforcement agencies and more than 90 public safety answering points. The Contractor must have the ability to call the appropriate public safety answering point based on the nature and location of the alert. The system shall also have the ability to supplement live calls with automated voice notification and text messaging.

3. To protect against failure of the Contractor's central host system and software, the Contractor shall have a fully redundant system that is maintained in a geographically different location. The redundant system shall allow for the seamless continuation of all services and the protection of all data in the event of a disaster or other disruption to the central host system.
4. The Contractor shall offer toll-free access to live technical support personnel, who shall be available 24 hours per day, seven days per week. Support shall be provided at no additional cost to the Department and shall include but not be limited to troubleshooting, event interpretation, and application questions. If the technical support personnel cannot remedy the issue, the Contractor shall provide a response to the Department within 24 hours.
5. The Contractor shall provide on-site technical support when required. This on-site support may be requested when it is determined the problem cannot be corrected by telephone or email.
6. The Contractor shall appoint a liaison for the Department to periodically discuss contract performance.
7. The Contractor shall be responsible for the maintenance and repair/replacement of all equipment for the duration of the contract at no additional cost. The Contractor shall repair/replace equipment within 24 hours from the time the equipment problem was identified. The Contractor shall be responsible for all equipment shipping costs in either direction.
8. The Contractor shall be able to fulfill the Department's request for additional tracking devices within 24 hours and shall be responsible for all equipment shipping costs.
9. The Contractor shall provide without fee, as an inventory allowance, at least an additional 20% of the total number of units that are in use.
10. The Contractor must furnish all necessary tools to attach and remove the bracelet device and/or straps at no additional cost.
11. The Contractor must supply all replaceable or rechargeable batteries at no additional cost.
12. The Contractor shall be able to provide testimony regarding the performance and methodologies of the Contractor's equipment and services as requested by the Department and/or court.
13. The Contractor shall also provide material to be used to instruct offenders and, when appropriate, victims on the use and care of the equipment.

14. The Contractor shall provide to all its affected employees prior to program implementation written policies and procedures in order to ensure compliance with the requirements in this contract.

15. The Contractor should be able to retrieve monitoring equipment located in participants' residences within 12 hours following notification from the Department of program completion. Contractor should be able to repair/replace malfunctioning equipment at participants' residences within two hours of notification from the department.

Part 2: Juvenile Probation Department

I. USING DEPARTMENT BACKGROUND INFORMATION

The Juvenile Probation and Court Services Department of the Circuit Court of Cook County uses electronic monitoring equipment and services to monitor juvenile offenders throughout Cook County.

II. CURRENT SOLUTION / METHOD

The contractor must be able to provide service for these units or provide comparable equipment at a competitive daily rate.

The contract must meet all standards contained in this section. These standards supplement, and do not replace, requirements for compliance with all applicable laws, regulations and policies regarding provision of services to the Circuit Court and Cook County.

III. REQUIREMENTS

A. General System Requirements for GPS Tracking Software

1. The software system shall be capable of identifying all alerts in real time 24 hours per day, 7 days per week and of notifying the Department immediately.
2. A system that allows communication with the juvenile offender, preferably voice communication, is not required but if available should be highlighted. This functionality must be identified separately in the cost proposal.
3. The system shall be capable of providing the Department alert notification via telephone, pager, internet and email.
4. The system shall immediately generate an alert that is specifically identified by type (e.g., exclusion zone alert, inclusion zone alert, tamper alert, low-battery alert, etc.) in the event of any of the following:
 - i. The receiver or bracelet strap has been tampered with;
 - ii. The device is no longer tracking (e.g., no GPS signal);
 - iii. The receiver battery is low or dead;
 - iv. The receiver is not charged (if applicable) according to a predefined schedule;
 - v. The receiver is unable to communicate with the Contractor's monitoring software due to communications failure (e.g., when the system cannot send data due to problems with cell communications);
 - vi. The system detects a zone infraction (e.g., exclusion, inclusion, and mobile);
 - vii. The GPS receiver is in motion but is not being tracked by GPS;
 - viii. The bracelet battery is low or dead (two-piece systems);
 - ix. The equipment malfunctions in any other manner not specified above.

5. The central host system, the repository of all monitoring data, shall not be located in the Department's facility and shall be the responsibility of the Contractor.
6. All device communications with a monitoring center must be toll-free to the participant.
7. The GPS systems must be capable of operating in primarily urban and suburban environments.
8. GPS systems must be capable of detecting location accuracy within 10 feet.
9. The system must utilize a supplemental or an enhanced tracking system when GPS is unavailable or diminished.

B. Device/Hardware Requirements for Electronic Monitoring Devices

1. Device components shall comply with applicable Federal Communications Commission (FCC) regulations and shall be registered with the FCC;
2. GPS receivers shall be capable of communicating with the U.S. Government Global Positioning System;
3. The receivers must be capable of operating normally when in proximity to other receivers and other electronic devices (e.g., cell phones, satellite television receivers, microwave ovens, computers, and radio towers);
4. The receiver shall be capable of collecting data at least once every minute;
5. The receiver shall transmit data to the monitoring system on a near-real time basis;
6. The receiver shall have an internal clock and include the date and time of all recorded events;
7. The receiver shall be capable of recording and storing a minimum of 1-2 days of location data in the event of a communication disruption with the central host system (e.g., power outage, no cellular coverage). The unit shall transmit stored data to the monitoring center as soon as communication is restored and all alerts shall be specified and responded to appropriately;
8. The receivers shall have a signal acquisition time of no more than 10 minutes;
9. The tracking unit shall not pose a safety hazard to the offender or others;
10. Device components shall be tamper-resistant and the bracelet component should be tamper-evident such that any attempt to remove it will leave physical evidence of the attempt;
11. Device components shall reliably function in environmental and atmospheric conditions that will normally be encountered;

12. Device components shall be capable of enduring shock and vibration associated with normal wear and use;
13. Device components which are physically attached to the juvenile offender shall be moisture and water resistant for such normal activities as bathing, showering, and sweating;
14. The monitoring unit shall have internal diagnostics that can determine if it is operating properly and it must have the ability to relay this information to the central monitoring center;
15. The receiver signal shall be unique to the individual to whom it is assigned;
16. The bracelet component shall be hypoallergenic;
17. The receiver shall contain rechargeable batteries;
18. The receiver shall continue to receive and transmit location data while it is being charged;
19. The receiver should be fully charged within 2 hours;
20. The receiver should emit warnings when the battery charge is low;
21. The receiver must retain stored data when the battery is depleted;
22. The receiver should be capable of operating for a minimum of 24 hours on a single battery charge;
23. The unit should emit a low battery life warning in enough time to replace the battery;
24. The size and weight should be comfortable, portable, permit routine activities, and not interfere with normal activities or those related to manual labor jobs such as construction. Device components that physically attach to the juvenile offender must be able to fit to any size individual.

C. Software Requirements

1. The Contractor's central host system and software system shall be accessible to the Department via the Internet through a standard web browser interface. Access should accommodate up to 125 simultaneous users from the Department.
2. System shall track and display juvenile offender information including but not limited to the following: name; case number; date of birth; charge information; home, work and school addresses; juvenile and family telephone numbers (home, work, cell); physical descriptors (e.g., race, sex, height, and weight, identifying marks (tattoos)); the assigned supervision officer(s); assigned electronic monitoring device(s); alert and notification

protocols; current monitoring status; tracking history and zones (see below #4). Also, the software system should provide the ability to store the juvenile offender's photo.

3. The software system shall provide the ability to configure alert protocols that are unique to each juvenile offender and to configure alert protocols for certain groups of juvenile offenders.
4. The software system shall have the ability to display the status and history of the alerts identified in the previous section, "General System Requirements."
5. The software system shall provide the ability to view and manage the equipment inventory applicable to the Department.
6. The software system shall provide the ability to generate juvenile offender specific location reports (for GPS), inventory reports and management reports. The system shall have the ability to query, sort, and search by any field.
7. The software system shall display the physical location of the offender on a user-friendly interactive map containing recognizable state, county, municipality, and street names. Every GPS point recorded shall be displayed and the direction and speed of travel indicated. The system should provide the ability to conduct a reverse geocode search in which a known location data point is used to look up the nearest physical address.
8. The software system shall provide the ability to establish and edit exclusion zones and inclusion zones and should have the ability to establish and edit travel zones; jurisdictional zones and buffer zones.
9. The software system shall provide the ability to configure multiple schedules for a single juvenile offender (e.g., weekday and weekend schedules).
10. The software system shall provide the ability to establish zones for individual juvenile offenders and for groups of juvenile offenders.
11. The software system should be able to create polygon shaped zones.
12. The software system shall provide the ability to print maps of a juvenile's location points that indicate the direction of travel.

D. Data and System Security Requirements

1. Each authorized user must be able to access the Contractor's software in a secure manner.
2. The Department's data that is stored in the Contractor's software must be protected to ensure there is no unauthorized access.
3. Contractor must have sound procedures (e.g., background checks, hiring practices, etc.) for ensuring its employees are properly authorized for access to confidential and sensitive information on juveniles involved in the juvenile justice system. The Contractor shall ensure the confidentiality of juvenile offender records is maintained and shall not disclose any such information to any third party without written authorization of the Department.
4. The Contractor should be able to create user groups with varying access privileges (e.g., read/write and read only).

5. Each juvenile offender's data shall be accessible for a minimum of 6 months before it is archived or stored offline.
6. Archived copies of each juvenile offender's data shall be retained for a minimum of 7 years and/or provided in a format that can be stored and easily interpreted by the Department.
7. The Contractor shall backup the system data at least every 24 hours.
8. Data generated shall be owned by the Department and may not be used in any way by the Contractor without consent of the Department. The Contractor shall ensure that all data is available to the Department in the event the contract is terminated or the Contractor goes out of business.

E. Services Requirements

1. The Contractor's monitoring center shall be capable of providing services 24 hours a day, 7 days a week.
2. The Contractor's monitoring center shall be capable of conducting alert analysis and resolution using Department defined protocols, which will include notifying the Department of all alerts. Alert analysis and resolution must begin immediately upon receiving an alert and must be completed promptly.
3. To protect against failure of the Contractor's central host system and software, the Contractor shall have a fully redundant system that is maintained in a geographically different location. The redundant system shall allow for the seamless continuation of all services and the protection of all data in the event of a disaster or other disruption to the central host system.
4. The Contractor shall offer toll-free access to live technical support personnel, who shall be available 24 hours per day, seven days per week. Support shall be provided at no additional cost to the Department and shall include but not be limited to troubleshooting, event interpretation, and application questions. If the technical support personnel cannot remedy the issue, the Contractor shall provide a response to the Department within 24 hours.
5. The Contractor shall provide on-site technical support when required. This on-site support may be requested when it is determined the problem cannot be corrected by telephone.
6. The Contractor shall appoint a liaison to the Department to participate in periodic meetings/discussions on contract performance.
7. The Contractor shall be responsible for the maintenance and repair/replacement of all equipment leased for the duration of the contract at no additional cost. The Contractor shall repair/replace equipment within 24 hours from the time the equipment problem was identified. The Contractor shall be responsible for all equipment shipping costs in both directions.

8. The Contractor shall be able to fulfill the Department's request for additional tracking devices within 24 hours and shall be responsible for all equipment shipping costs.
9. The Contractor shall provide without fee, as an unlimited allowance for lost, stolen, damaged receivers.
10. The Contractor shall provide an unlimited allowance ankle straps, charging cords for each piece of leased GPS equipment.
11. The Contractor must furnish all necessary tools to attach and remove the bracelet device and/or straps at no additional cost.
12. The Contractor must supply all replaceable or rechargeable batteries, pins and back-plates at no additional cost.
13. The Contractor shall be able to provide in-person testimony regarding the performance and methodologies of the Proposer's equipment and services as requested by the Department and/or court.
14. The Contractor shall provide material to be used to instruct juvenile offenders on the use and care of the equipment.
15. **The Monitoring center shall have access to translation services 24 hours per day, seven days per week for communicating with victims that do not speak English.**

F. Intake Criteria

Clients will be identified and selected for the Electronic Monitoring by the Circuit Court of Cook County. All referrals authorized by the Court through the Juvenile Probation and Court Services Department will be on a no-decline basis. The Department will enroll, monitor and deactivate client's participating in the electronic monitoring program. Contractor must detail their equipment's enrollment and de-activation protocols.

G. Number of Youth Served

The Contractor must be able to service 420 active GPS electronic monitoring units at any given time.

Part 4: Additional Requirements

THE FOLLOWING SHALL APPLY TO BOTH USING DEPARTMENTS:

I. Training

The Contractor shall provide at no additional cost, on-site training for each Department's staff and other agency personnel deemed appropriate in all topics necessary for the implementation of the monitoring system. Each Department shall choose the dates and locations of the training. Training shall minimally cover the following: installation and

removal of equipment; offender enrollment; juvenile offender enrollment; zone and schedule creation and modification; use of the monitoring system and software; troubleshooting; alert notification protocols; and any other areas deemed necessary. The training shall be delivered by knowledgeable and experienced persons and shall include the provision of detailed, written instructions for the participants. Training shall occur prior to implementation, annually for booster sessions, and additionally as requested by each Department when it is required to properly implement and operate the monitoring program (e.g., when new equipment or software is introduced, when there is a major change in Department personnel, or when there is an ongoing problem that could be addressed through training).

- A. The Contractor shall provide for and conduct sufficient initial (a minimum of 1 full day of training per department) and periodic training classes to Department personnel.
- B. Training shall be sufficient in nature so the appropriate staff is comfortable with the use and installation of all electronic monitoring equipment, software and operation.
- C. The Contractor shall provide for necessary training to Department personnel in the event there is any change in equipment or software utilized.
- D. The Contractor shall provide initial training and periodic training to their employees to maintain compliance with all of the requirements stated in this request for proposal.

II. Performance Penalty Adjustments

The County may assess a penalty in the event a Contractor fails to provide satisfactory levels of service as requested in this CONTRACT. Penalties may be assessed for the following reasons:

- A. Failure to notify the Department of participant violations alerts, or inaccurate participant counts.
- B. Failure to maintain adequate equipment inventory.
- C. Failure to provide requested reports.
- D. Failure to provide adequate training for Proposer or Department personnel.
- E. Failure to perform any of the CONTRACT terms, which results in significant impairment of the monitoring services.

The amount of the penalty shall be a minimum of \$1.00 up to the total cost of the daily participant fee per affected participant per day. Performance penalties shall not be applied before five (5) days written notice is given from the Department to the Contractor. An appeal process acceptable to the Department and the Contractor may be developed once the contract is awarded.

III. Confidentiality and Ownership of Documents

Contractor acknowledges and agrees that information regarding this Contract is confidential and shall not be disclosed, directly, indirectly or by implication, or be used by Contractor in any way,

whether during the term of this Contract or at any time thereafter, except solely as required in the course of Contractor's performance hereunder. Contractor shall comply with the applicable privacy laws and regulations affecting County and will not disclose any of County's records, materials, or other data to any third party. Contractor shall not have the right to compile and distribute statistical analyses and reports utilizing data derived from information or data obtained from County without the prior written approval of County. In the event such approval is given, any such reports published and distributed by Contractor shall be furnished to County without charge.


