**AMENDMENT NO. 1**

This Amendment modifies Contract No. 11-28-043, for Job Order Contracting (JOC) Consultant Services by and between the County of Cook, Illinois, herein referred to as "County" and The Gordian Group, Inc., authorized to do business in the State of Illinois hereinafter referred to as "Consultant":

**RECITALS**

Whereas, the County and Consultant have entered into a Contract approved by the County Board on May 14, 2012, (hereinafter referred to as the "Contract"), wherein the Contractor is to provide JOC consulting services (hereinafter referred to as the "Services") from May 1, 2012 through April 30, 2015, in an amount not to exceed \$1,050,000.00; and

Whereas, an increase in the amount of \$2,500,000.00 is required for the continuation of Services; and

Now therefore, in consideration of mutual covenants contained herein, it is agreed by and between the parties to amend the Contract as follows:

1. The Contract is increased by \$2,500,000.00 and the Total Contract Amount is revised to \$3,550,000.00.



This consent may be executed in counterparts and by facsimile or electronically transmitted signature, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.


