

AMENDMENT NO. 3

This Third Amendment modifies Contract No. 11-84-038 for Food Service Management by and between the County of Cook, Illinois, herein referred to as "County" and CBM Premier Management, LLC, authorized to do business in the State of Illinois hereinafter referred to as "Contractor":

RECITALS

Whereas, the County and Contractor have entered into a Contract approved by the County Board on July 24, 2012, (hereinafter referred to as the "Contract"), wherein the Contractor is to provide food service management (hereinafter referred to as the "Services") from July 24, 2012 through July 23, 2015 in an amount not to exceed \$38,360,583.23; and

Whereas, Amendment # 1 was executed on July 24, 2012 for the purpose of naming subcontractors; and

Whereas, Amendment # 2 was executed on February 18, 2014 to increase the contract in the amount of \$570,359.78 for a rate adjustment based on the CPI; and

Whereas, the contract provisions allow a rate adjustment based on the CPI each year after the year one base period; and

Whereas, the rate adjustment calculations are indicated in the attached Exhibit A; and

Whereas, an increase in the amount of \$293,222.83 is required for the continuation of Services.


Now therefore, in consideration of mutual covenants contained herein, it is agreed by and between the parties to amend the Contract as follows:


1. The Contract is increased by \$293,222.83 and the Total Contract Amount is revised to \$39,224,165.84.
2. This Contract is hereby amended to incorporate Exhibit A and made part of the Contract.
3. All other terms and conditions remain as stated in the Contract.


