

AMENDMENT NO. 30

This Amendment modifies Contract No. 11-84-167B, for Computer Hardware by and between the County of Cook, Illinois, herein referred to as "County" and MoreDirect, Inc., authorized to do business in the State of Illinois hereinafter referred to as "Contractor":

RECITALS

Whereas, the County and Contractor have entered into a Contract authorized by the County Board on June 5, 2012, (hereinafter referred to as the "Contract"), wherein the Contractor is to provide Computer Hardware (hereinafter referred to as the "Supplies") from July 1, 2012 through June 30, 2015, with two, one-year renewal options, in an amount not to exceed \$9,716,223.00; and

Whereas, Amendment No. 20 was authorized by the Chief Procurement Officer on June 10, 2015 to renew contract for one year beginning on July 1, 2015 through June 30, 2016; and

Whereas, Amendment No. 28 was authorized by the County Board on May 11, 2016 to renew contract of one year beginning on July 1, 2016 through June 30, 2017; and

Whereas, the County and Contractor desires to include additional Supplies to the Contract.

Now therefore, in consideration of mutual covenants contained herein, it is agreed by and between the parties to amend the Contract as follows:

1. The Contract is hereby amended to incorporate Exhibit A of this Amendment and made part of the Contract.
3. All other terms and conditions remain as stated in the Contract.
