

AMENDMENT NO. 4

This Amendment modifies Contract No. 11-85-133, for Personal Hygiene Supplies by and between the County of Cook, Illinois, herein referred to as "County" and Pacific Care Products, authorized to do business in the State of Illinois hereinafter referred to as "Contractor":

RECITALS

Whereas, the County and Contractor have entered into a Contract approved by the County Board on April 3, 2012, (hereinafter referred to as the "Contract"), wherein the Contractor is to provide Personal Hygiene Supplies (hereinafter referred to as the "Supplies") from April 3, 2012 through April 2, 2014, with three (3) one-year renewal options, in an amount not to exceed \$659,170.00; and

Whereas, Amendment # 1 was executed on October 2, 2012 for additional items in the amount of \$415,800.00; and

Whereas, Amendment # 2 was executed on April 21, 2014 to exercise the first of three renewal options to extend the contract for twelve (12) months beginning April 3, 2014 through April 2, 2015 in the amount of \$329,820.00; and

Whereas, Amendment #3 was executed on April 13, 2015 to exercise the second of three (3) renewal options to extend the contract for twelve (12) months beginning April 3, 2015 through April 2, 2016 and allow a price increase not to exceed 3%;

Whereas, pursuant to GC-14 "Modifications and Amendments", the Contractor and County desire to add additional supplies and delivery locations to the Contract:

Whereas, an increase in the amount of \$39,546.40 is required for additional Supplies; and

Now therefore, in consideration of mutual covenants contained herein, it is agreed by and between the parties to amend the Contract as follows:

1. The Contract is increased by \$39,546.40 and the Total Contract Amount is revised to \$1,791,139.40.
2. The Contract is hereby amended to incorporate Attachment A and made part of the Contract.
3. All other terms and conditions remain as stated in the Contract.
