

**AMENDMENT NO. 1**

This First Amendment modifies Contract No 1411-13815 for Police Pursuit Vehicles by and between the County of Cook, Illinois, herein referred to as "County" and Tri-Angle Fabrication & Body, Co., authorized to do business in the State of Illinois hereinafter referred to as "Contractor":

**RECITALS**

Whereas, the County and Contractor have entered into a Contract approved by the County Board on October 8, 2014, (hereinafter referred to as the "Contract"), wherein the Contractor is to provide police pursuit vehicles (hereinafter referred to as the "Supplies") from October 8, 2014 through October 7, 2016, in an amount not to exceed \$1,234,737.84; and

Whereas, an increase in the amount of \$1,343,870.00 is required for the addition of Supplies; and

Whereas, the County and Contractor desire to include additional supplies to the Contract.

Now therefore, in consideration of mutual covenants contained herein, it is agreed by and between the parties to amend the Contract as follows:

1. The Contract is increased by \$1,343,870.00 and the Total Contract Amount is revised to \$2,578,607.84.
2. The Contract is hereby amended to incorporate Attachment "A" and made part of the Contract.
3. The attached Economic Disclosures Statement form is incorporated and made a part of this Contract
4. All other terms and conditions remain as stated in the Contract.
