REHEARING- Reference #V-15-50 Jean Yang (Owner/Applicant) The Subject Property consists of approximately 0.25 acres located on the southeast corner of Glenview Road and Glenwood Road in Northfield Township (Cook County Board District #14). The Variation, as requested, seeks to reduce the right interior side yard setback from the minimum required 10 feet to a proposed 7.18 feet in the R-5 Single Family Residence District.
