**Reference - V 14-62 Thomas Schulz**- (Owner/Applicant). The Subject Property consists of approximately 0.615 acre located on the East side of Martin Drive approximately 401 feet North of Northwest Highway in Palatine Township (Cook County Board District #14). The Variation as requested seeks to: (1) reduce the front yard setback from the minimum required 40 feet to a proposed 37 feet 2 ½ inches, (2) reduce left interior side yard setback from 15 feet to a proposed 10 1 5/8 inches; and (3) reduce the right side yard setback from minimum required 15 feet to an existing 3.41 feet for an addition in the R-4 Single Family Residence District.
