The following is a schedule of a public hearing to be held on **Wednesday, January 21st, 2015 at 1:00 P.M.**, 69 West Washington, in Suite 2840, Chicago, IL.

Reference - V 15-03 Michael Tresch- (Owner) Lisa Casas On-Time Expediting Inc. (Applicant). The Subject Property consists of approximately 0.09 acres located on the East side of Latrobe Avenue, approximately 150 feet South of 49th Street in Stickney Township (Cook County Board District #16). The Variation as requested seeks to: (1) reduce the front yard setback from the minimum required 25 feet @ 20% of lot depth to a proposed 18.50 feet, (2) reduce left and right interior side yard setbacks from the minimum required 10 feet to a proposed 3 feet; and (3) increase the floor area ratio from the maximum allowed 0.40 to 0.44 to construct a single family residence with detached garage in the R-5 Single Family Residence District. The commonly known address is 4911 S. Latrobe Avenue, Chicago, Illinois.
