

AMENDMENT NO. 2

This Amendment modifies Contract No. 2185-18595, for Renovation 7th and 11th Floor, County Building and Real Estate Development for Oak Forest Campus by and between the County of Cook, Illinois, herein referred to as "County" and FGM Architects Inc., authorized to do business in the State of Illinois hereinafter referred to as "Contractor":

RECITALS

Whereas, the County and Contractor have entered into a Contract approved by the County Board on October 19, 2023, (hereinafter referred to as the "Contract"), wherein the Contractor is to provide Renovation 7th and 11th Floor, County Building and Real Estate Development for Oak Forest Campus (hereinafter referred to as the "Services") from November 1, 2023 to October 31, 2026, in an amount not to exceed \$4,992,609.09, with two (2), one-year renewal options; and

Whereas, Amendment No. 1 was authorized by the County Board on April 10, 2025 to increase the contract in the amount of \$246,025.00 and the Total Contract Amount was revised to \$5,238,634.09; and

Whereas, the Contract will expire October 31, 2026, and the agreed upon Services are still required; and

Whereas, pursuant to Article 1 Section 1.2.1. of the Contract, the County and Contractor desire to renew the Contract for one year beginning on November 1, 2026 through October 31, 2027. Whereas, an increase of the Contract amount is required for the continuation of Services; and pursuant to Article 3 Section 3.1.4 of the Contract, the County and Contractor desire to increase the Contract in the amount of \$286,000.00.

Whereas, pursuant to Section 2.15.23. of the Contract, the County and Contractor desire to include additional scope of services to the Contract; and

Now therefore, in consideration of mutual covenants contained herein, it is agreed by and between the parties to amend the Contract as follows:

1. The Contract is renewed through October 31, 2027.
2. The Contract is increased by \$286,000.00 and the Total Contract Amount is revised to \$5,524,634.09.
3. The Contract is hereby amended to incorporate Attachment A and made part of the Contract.
4. The attached updated Identification of Sub-Contractors/Suppliers/Sub-Consultants Form (if applicable and updated), MBE/WBE Utilization Plan forms (if applicable and updated), certificate of insurance (if updated), and Economic Disclosures Statement under Attachment B are incorporated and made a part of this Contract.
5. All other terms and conditions remain as stated in the Contract.

Dear Larry,

We are pleased to offer the following Additional Service Request (AS-2) to provide input and coordination for the critical stabilization efforts around the nine proposed buildings and campus quadrangles for potential preservation and ongoing program management of the effort.

Summary:

The CCS/FGMA team is nearing completion of the Basic Services Part One and Part Two, which will culminate with a Master development framework plan and strategic recommendations to guide the advancement toward predevelopment tasks, new investment and implementation. As part of the Additional Services 1 and in collaboration with the County's demolition Team, we assessed the potential for preservation of some of the key existing structures and campus features since this study had never been undertaken in prior efforts. As a result, this led to an initial assessment of potentials savings of time and money through preservation, and further recommendation to pursue critical stabilization and "mothballing" to secure these structures from continued degradation. Given the immediacy of pending winter conditions and potential to further jeopardize the condition of these buildings, our Team seeks to assist the County's Demolition team in defining the key tasks, directions and scope of work to inform and guide the architectural drawings for stabilization.

Further, Add Service Request AS-2 seeks ongoing scope and fee to cover the increase in contract time/services beyond the original 12-month duration and related increased level of services beyond the base scope as well as important predevelopment and due diligence tasks to ready the site for developer solicitation and ultimate redevelopment. Following the directions and recommendations evolving from the Master Development Plan, CCS/FGMA team seeks to advance these key tasks necessary for redevelopment and important to increase and attract development interest in a difficult site. As it exists today, the campus site is lacking key attributes required by

The CCS/FGMA team has begun some of these services in good faith to accommodate near term schedule demands with a focus on critical near-term efforts, including stabilization and program management. The duration of this scope will be determined in conjunction with Cook County. Some of these efforts, particularly those requiring public process and a negotiation period may be less than or exceed current time projections. CCS/FGMA will track the time and effort through 2025 and notify the County if tasks are exceeding the projected timeframes included in this scope/fee proposal. Should efforts exceed the timeframes, CCS/FGMA will prepare a proposal to accommodate this extension through completion.

Proposed Fee:

Our team will provide the services above on a **TIME AND MATERIAL** basis.

We anticipate the fee will be as outlined below. The final amount and allocation per firm is subject to change and may result in fees less than or more than those outlined below.

Note: Scope of services indicated under AS2.02 are required to successfully complete the project. Per the County's request, they are removed from this amendment and will be included in a future Amendment. The overall project schedule and cost associated with these services may be affected depending on when the future amendment is approved.

There were changes in area, scope of services requested, etc. While the overall contract value remained the same for the project, the allocations of those funds were adjusted to reflect the new scope of services. Some firms had increases, others had decreases.

NIA Architects replaced by HUS Architecture. The change was requested by FGMA due to employee turn-over and the current staff availability at NIA. FGMA does not feel that NIA Architects can provide the level service necessary for their role as associate architect on the project. FGMA has selected HUS Architecture (COC WBE CF) to perform the scope of services initially allocated to NIA Architects. The scope of services will generally remain the same, except for some reallocation of services to later phases of the project and a slight reduction in fees due to the consultant starting later in the process. Clarification 02 Scope Revisions, The Scope of Work and Scope of Services were adjusted in Clarification 02 as outlined in the attached narrative. The overall project fee remains the same, but the allocation has been adjusted to reflect the changes. Nia provided a letter agreeing to their removal from the contract. In addition, FGMA is increasing the participation of existing subs Specialty Consulting (CC AAPI M) increasing commitment from 1.61% to 1.84% Johnson Research Group (Cook County WBE C F) from 2.25% to 2.29, Specialty Consulting Group (Cook MBE HA M) goes from 1.61% to 1.84% and Rubinos (CC MBE HA M) increasing participation from 3.38% to 4.11%. Overall MWBE commitment goes from 38.4% 39.05%

3.2.3. Reduction of Professional Services.

In the event the County reduces the scope of services, the Consultant will be entitled to compensation for services actually rendered and authorized Reimbursable Expenses actually incurred in accordance with Articles 6 Basis of Compensation and 7 Payments to the Consultant.

ARTICLE 4. INSURANCE AND INDEMNIFICATION

4.1. Insurance.
